Official Election Results for the August 6, 2013 Special Election are attached to the Election Summary Report.


SUMMARY OF OFFICIAL CANVASS

There were a total of 1,215 ballots tabulated for the August 6, 2013 Special Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 441 valid Absentee/Vote by Mail applications. Of those requests, 419 ballots were returned (95.01%). The Ballot Department tabulated 412 Absentee / Vote by Mail Ballots (98.32%) of the applications processed. There were 7 ballots challenged in this election resulting in a challenge rate of 1.68%*. Details of the challenges are below.

*The Absentee Ballot Challenge Rate is 0.71% when the Absentee Ballots postmarked after the deadline are excluded.



OVER VOTES

There were no over votes recorded, resulting in a 0.00% over vote rate for the election. The exact number of over voted ballots is unknown as the Unity system reports over votes on a per-contest basis, thus a ballot containing multiple over votes is recorded multiple times.

VOTER HISTORY (PHASE 1)

Eight (8) precincts were involved in this election. The number of signatures in the Poll Books matches the number of Ballots Cast in 8 (100%) precincts. AUDIT

The post-election audit will begin on Wednesday, September 4, 2013 at 10:00 a.m. This audit will be conducted using the precinct batch based risk limiting audit method. The Board will randomly select the contest in which the audit will be conducted. If a requested recount is required, the recount will be performed instead of the audit.





Voter Turn Out by Category






Election Day Voting Trend

Provisional Voting Trend




