
Final Election Results for the February 8, 2011 Special Election are attached in the Election Summary Report.




ABSENTEE VOTING SUMMARY

A total of 5,950 voters requested a Vote by Mail/Absentee Ballot. Of those requests, 5,279 ballots were returned (88.7%). The Ballot Department counted 5,188 (87.1%) Vote by Mail/Absentee Ballots, the remaining 92 were challenged for the reasons listed below.


Percentage of Challenges by Category



The above graph illustrates the number of Absentee Ballots challenged in comparison to the total number of Absentee Ballots returned to the Board of Elections for previous Special Elections.


PROVISIONAL VOTING SUMMARY


Percentage of Rejections by Category



BALLOT RE-MAKES

A total of 16 ballots were remade in accordance with the CCBOE Remake Procedure approved by the Board on August 24, 2010. During the Unofficial Canvass we processed 15 remakes; the remaining remake was processed during the Official Canvass. A breakdown by category is below:

1 - Ripped or torn ballot.	12
2 - One oval is dark and another oval is lightly marked.	1
3 - One choice is crossed out, the intent is clear.	1
12 - Green ink was used to fill in an oval(s).	2

RECOUNTS

There are no automatic recounts for this election. The deadline for a requested recount is Monday, March 7, 2011.

OVER-VOTES

A total of 2 over-voted races were recorded in this Special Election. This is a 0.03% over-vote rate.

DOUBLE-VOTING

There were no instances of double voting in this election.

POLL BOOK JUSTIFICATION AND BALLOT RECONCILIATION

The number of signatures equals the number of Election Day ballots cast in each of the 25 precincts this election. The number of the ballots cast is also equivalent to the number of ballots issued.
