Constitutional – Attorney General

Robert Owens received 472 votes for the Constitutional Party Attorney General. Precinct by Precinct Results are attached.

Tie Vote

We have a tie vote in Maple Heights 04B for Democratic County Central Committee. Both Christy Johnson and Shavonne Y. Warley received 24 votes. ORC 3505.33 states that tie votes shall be resolved by lot by the chairman of the board in the presence of a majority of the members of the board. A coin flip to determine the winner will be necessary after this summary is presented.

Recounts

Two contests were decided by a margin of less than ½ of 1% of the votes cast. Automatic recounts are required in these contests pursuant to section 3515.011 of the Ohio Revised Code.

Candidates will be notified immediately following certification of the time and place of their recounts, which will begin on Tuesday June 1st.

Requests for additional recounts will be accepted through the close of business on June 1st, and will be scheduled for the following week.

Over-votes

A total of 2,345 over-voted races were recorded throughout the election. The exact number of ballots containing over-votes is not known because the UNITY system reports over-votes on a per-contest basis, so a single ballot is likely to contain multiple over-voted races. This equates to a 0.99% over-vote rate.

Double-voting

There is one instance of an individual that was discovered to have cast both a regular absentee ballot and a provisional ballot on Election Day. Both the absentee and provisional ballots were scanned and counted as part of the Unofficial Canvass. The provisional ballot was scanned by the voter in the DS200 on Election Day.

Poll Book Justification:

Out of 1,068 precincts in the county, there are currently 999 precincts where the number of signatures in the Alphabetical Poll Book equals the number of ballots cast in UNITY. In 69 precincts there is a difference of one or two signatures/votes between the ballots cast and signatures.

Amended Certification Summary:

Automatic Recounts were conducted on Tuesday, June 1, 2010 in two races:

- Maple Heights 04B Democratic Central Committee
- Shaker Heights 00W Democratic Central Committee

The Maple Heights 04B hand count matched the official count exactly. In Shaker Heights 00W we discovered two additional Election Day ballots – one democratic ballot, one nonpartisan ballot. The additional democratic ballot added one vote to the candidate who was originally winning the race. The new results are below.

- Rachel Eisenberg 93
- John P. Hyland 19
- Lisa Payne Jones 91

All of the Election Day ballots for Shaker Heights 00W were rescanned into a DS200. Results of the rescan match the hand count for the Democratic Central Committee race.

As a result of discovering two ballots during the recount in Shaker Heights 00W, the Ballot Department Staff went back to the 69 precincts which did not reconcile during the Poll Book Justification and hand counted the ballots. We found 8 precincts in which the hand count of the ballots did not match the number of ballots scanned on Election Day. All Election Day ballots in those 8 precincts were rescanned into DS200s and uploaded into UNITY. Details for each precinct are below.
