Final Election Results for the August 2, 2011 Special Election are attached in the "Election Summary Report."

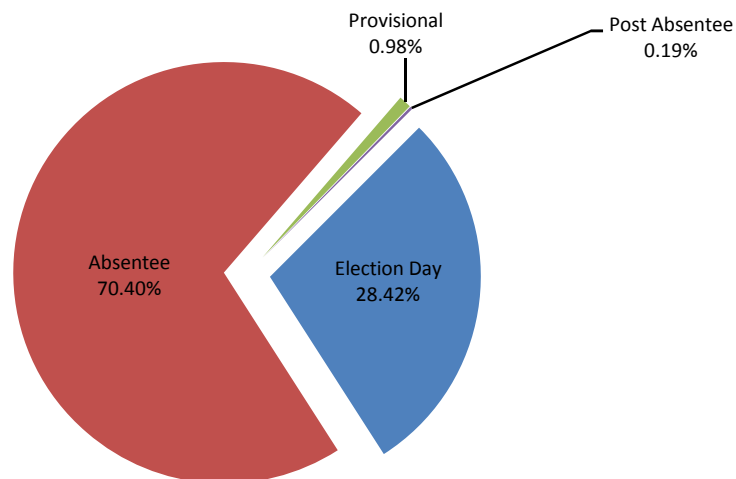

SUMMARY OF OFFICIAL CANVASS

There were 25,797 ballots counted for the August 2, 2011 Special Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 21,543 Absentee/Vote by Mail applications. Of those requests, 19,059 ballots were returned (88.47%). The Ballot Department tabulated 18,212 Absentee / Vote by Mail Ballots (84.54%). There were 847 ballots challenged in this election resulting in a challenge rate of 4.44%* for this election. Details of the challenges are below.

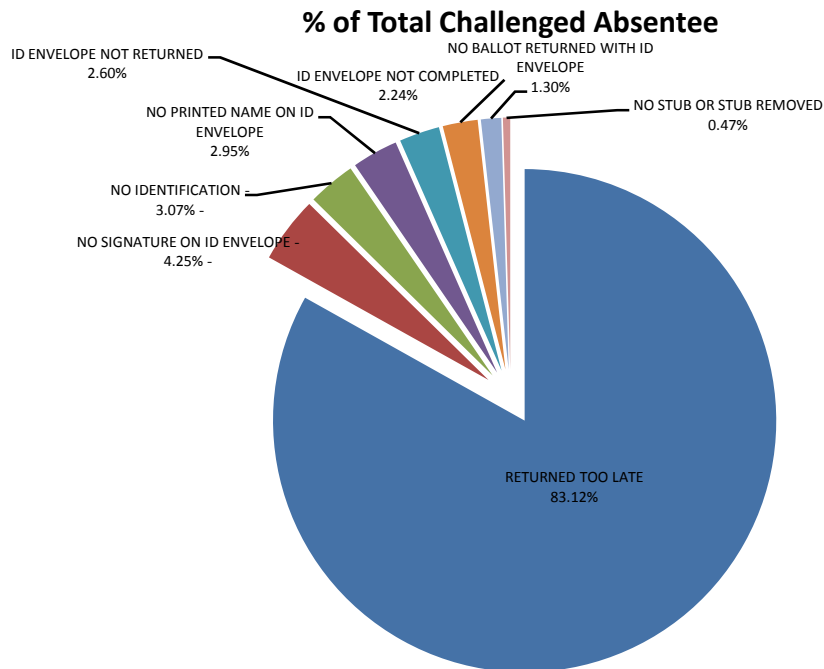

PROVISIONAL VOTING SUMMARY

A total of 287 Provisional Ballots were cast on Election Day and in-house (Absentee Provisional). Of those ballots, 253 (88.15%) were tabulated by the Ballot Department. There were thirty-four (34) rejected Provisional Ballots resulting in an 11.85%* rejection rate for this election. Details of the rejections are below.

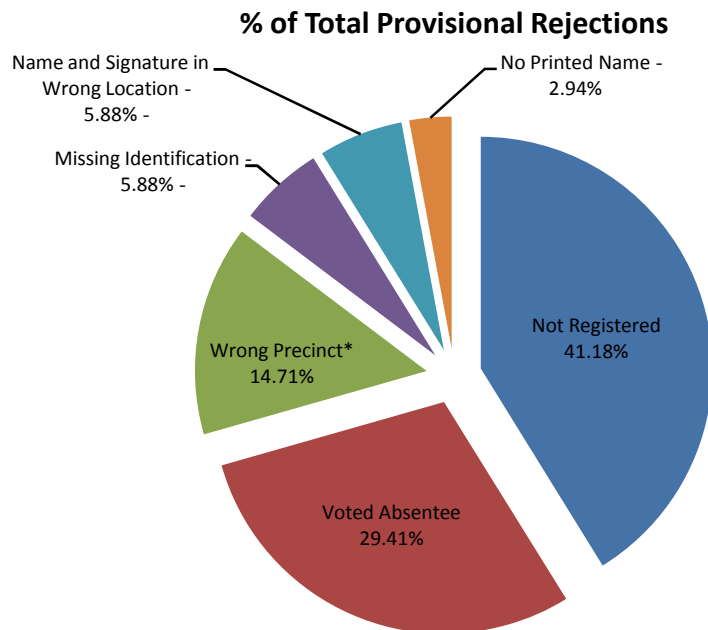

BALLOT REMAKES

During the election, twenty-six (26) ballots were processed in accordance with the CCBOE Remake Procedure (approved by the Board on August 4, 2010). All twenty-six (26) ballots were processed during the Unofficial Canvass. The following is a breakdown by category:

OVER VOTES

Fifteen (15) over votes were recorded resulting in a 0.05% over vote rate for the election. The exact number of over voted ballots is unknown as the Unity system reports over votes on a per-contest basis, thus a ballot containing multiple over votes is recorded multiple times. Details of the over votes by contest are below:

POLL BOOK JUSTIFICATION AND BALLOT RECONCILIATION

There were a total of seventy-five (75) precincts involved in this election. The number of signatures in the Poll Books matched the number of Ballots Cast in seventy-four (74) precincts. One precinct (Independence 00-D) had one more ballot cast than signatures in the Poll Book. A hand count of the ballots in the ballot box for this precinct confirms the total number uploaded into the tabulation software is accurate. There were no notations on the Election Day documentation sheets (Pink Memos) provided by the Poll Workers to explain this difference.

Every ballot ordered for each precinct, Election Day and In-House, has been accounted for in the Ballot Reconciliation process (ballots ordered = ballots voted + ballots soiled).

There are no automatic recounts for the August 2, 2011 Special Election. The deadline for Requested Recounts is Monday, August 29, 2011 at 4:30 PM.

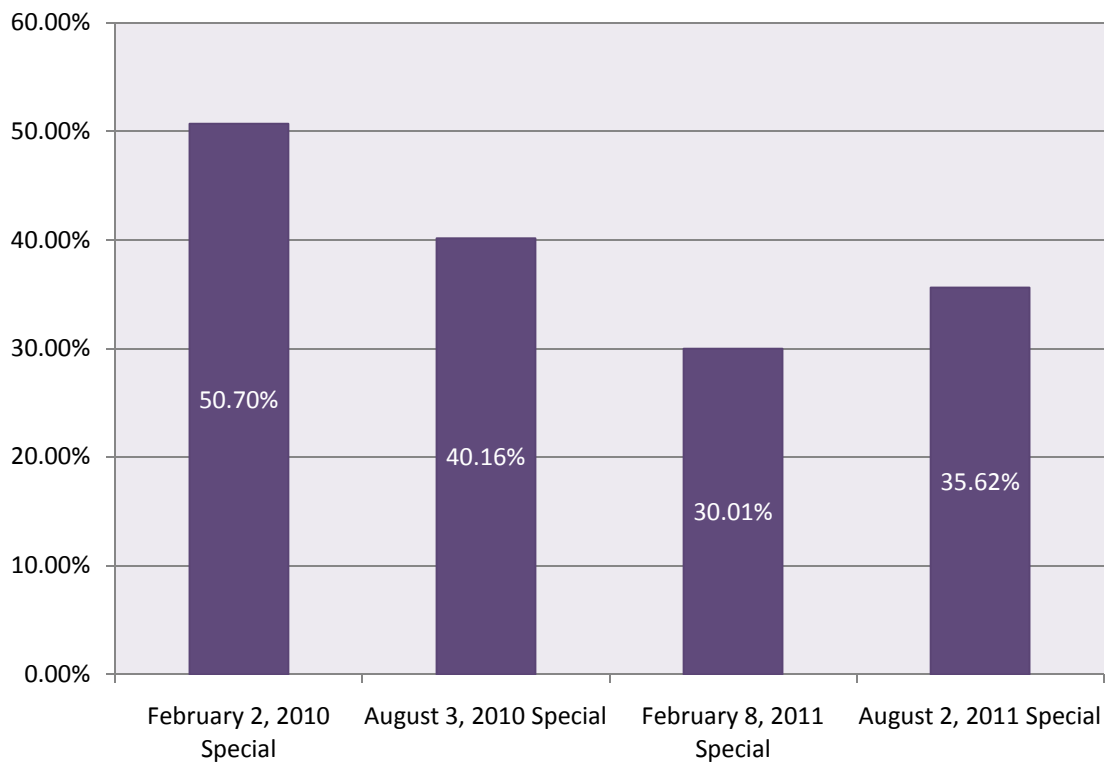
AUDITS

The Post-Election Audit for the August 2, 2011 Special Election will begin on Tuesday, September 6, 2011 at 10:00 AM.

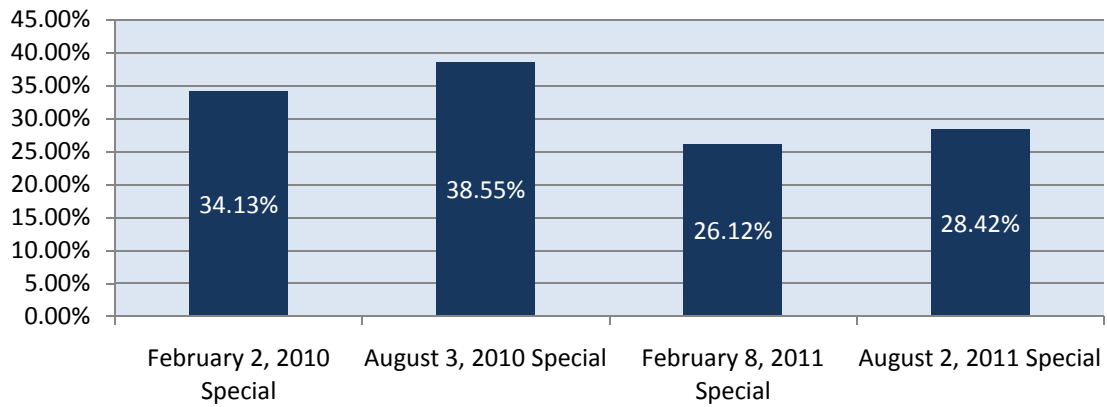

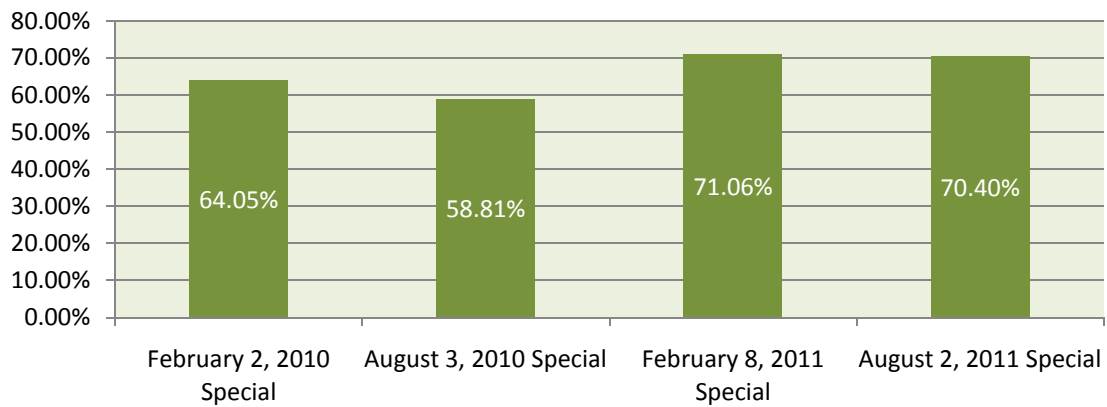
Voter Turnout



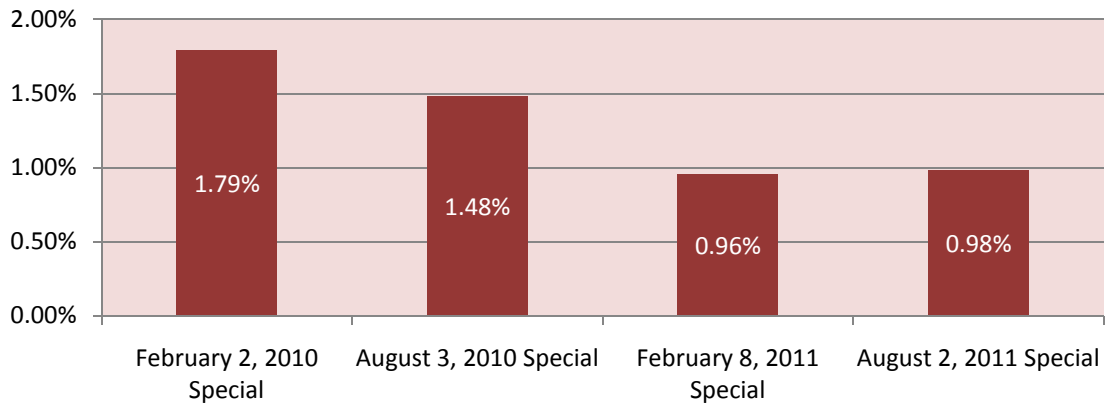
Election Day Voting Trend



Absentee Voting Trend



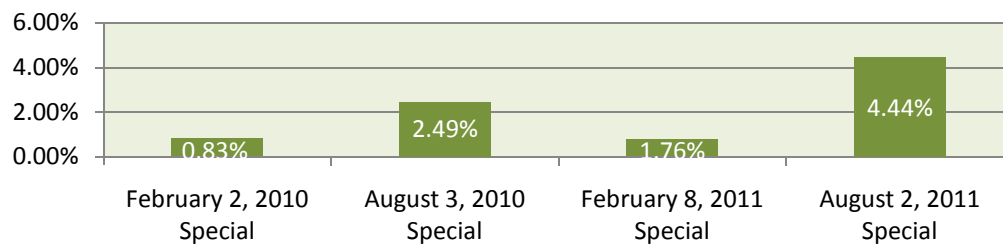
Provisional Voting Trend



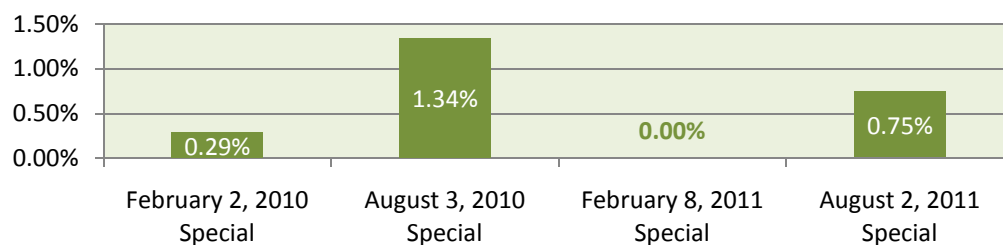

Challenge Rate



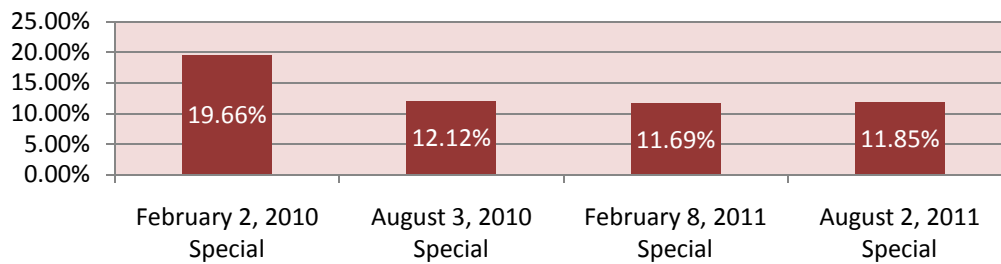
Challenge Rate (Excluding Late)



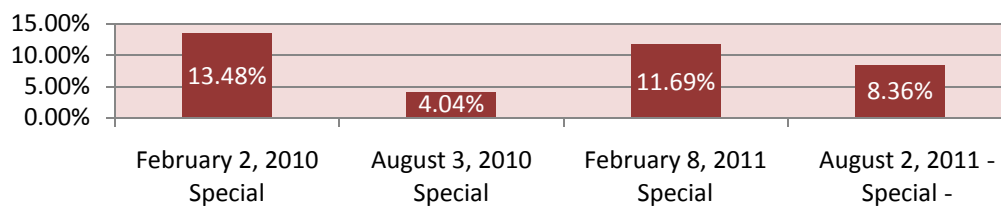
